The college is committed towards sustainable development in all its endeavours. Accordingly following areas are considered for streamlining the ways and procedures for the conservation of environment and energy.

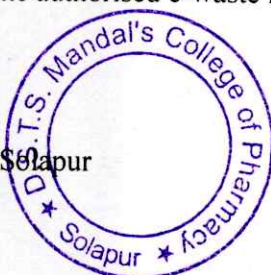
- A. Energy Conservation and Management
